## **PUBLIC NOTICE**

### **ORDINARY ELECTION TO RAMGARH CANTONMENT BOARD**

**(Rule 20 of the Cantonment Electoral Rules, 2007)**

#### **Reference Cantt Board Resolution No. 02 dt. 25.02.2023.**

WHEREAS the Central Government, in exercise of powers conferred under Section 15(1) of the Cantonments Act, 2006, vide Gazette of India Part II Section 4 Extraordinary, Notification S.R.O. 3(E). dated 17.02.2023 has notified 30.04.2023 as the date on which election to Ramgarh Cantonment Board shall be held.

NOW the Ramgarh Cantonment Board in pursuance of the said Gazette Notification S.R.O. 3(E). dated 17.02.2023 of the Central Government under the provision of Rule 20 of the Cantonment Electoral Rules, 2007 sets out hereunder.

(c) The symbols that may be chosen by candidates and the restriction to their choice shall be in accordance with the Election Symbols (Reservation and Allotment) Order, 1968 of Election Commission of India, as modified from time to time till date and the Notifications of the Election Commission of India issued in pursuance of the said orders, as amended from time to time till date. The allotment of symbols by the Returning Officer shall be governed by the provision of Rule 31(4 and 5) of the Cantonment Electoral Rules, 2007. The allotment of the symbols by the Returning Officer to a candidate shall be final.

(d) Attention of the public is invited to the Cantonment Electoral Rules, 2007 which governs the election of the members to the Board. The same is not available for sale but may be obtained from the

publication branch, Govt. of India, Delhi on payment. However, the same can be seen in the Cantonment Board Office.

(e) The nomination of a candidate is to be made in Form VI of Cantonment Electoral Rules, 2007 which can be had from the Cantonment Board Office, free of charge on application.

(f) Each candidate with his nomination paper shall deposit or cause to be deposited with the Returning Officer a sum of Rs 3,000/- (Rupees Three Thousand Only) in Cash Provided that when the candidate belongs to the Scheduled Caste or Scheduled Tribe the amount of such deposit shall be Rs 1500/ (Rupees one thousand five hundred only).

(g) The scrutiny of nomination papers shall be undertaken at the Ramgarh Cantonment Board Office at the date and time mentioned in the election programme. The only person permitted to be present shall be the candidate or his election agent or his proposer.
